COMMUNICATIONS FROM THE PUBLIC

The person will be called to speak when the agenda item comes before City Council for discussion or action. Comments are limited to 3 minutes.

PUBLIC HEARING

The purpose of the Public Hearing is to receive input from the public, either oral or written, regarding the 2025-2026 City of Waller Operating Budget for the fiscal year beginning October 1, 2025, and ending September 30, 2026.
